Dear Mr. York:

I am writing this letter in response to the attached letter regarding S. Clarke International in the hopes that we can resolve the issue without your pursuing legal remedies.

If I may, please, explain how this situation developed. When we moved to Florida in 1995 and started our business here under the name of Clarke Waste Systems (properly registered and all fees current!), S. Clarke International, an Oregon corporation, was basically dormant. Then as we grew Clarke Waste Systems, we began to do more and more international business in the Islands and South America. I wanted a way to track these international sales separately so I got the "bright idea" of having Clarke Waste Systems transfer inventory to S. Clarke International at cost and S. Clarke International sell to the end customers. In my mind (and after consultation with our accountant) this was just my way of accounting for this type of sales. Our accountant's opinion was that as long as were selling at cost (with no profit involved) this would be OK.

Additionally, in early 2001 we were beginning to work with SunTrust Bank to obtain financing to build a new building for Clarke Waste Systems in Pompano Beach. There were reams and reams of documentation that they required, one item being certificates of good standing for both Clarke Waste Systems and S. Clarke International. Well, at this point, I didn't have one for S. Clarke International since I had only been using it for "bookkeeping purposes" so I sent in the application form for a registration of a foreign corporation and as a result of my honesty in giving the 1997 date as "start of business" I was assessed with the fine of \$4,600.

When I explained this situation to the bank they agreed that for their purposes, if I dissolved S. Clarke International and processed all sales through Clarke Waste Systems, their requirements were satisfied. Which is what I did. S. Clarke International had been formed in the State of Oregon and remained an active corporation there until dissolution on August 22, 2001.

You may also be wondering why it took so long for me to respond. After I received your first letter, I spoke to both my accountant and attorney. They were both surprised at my predicament and said "why don't you just sit on it for awhile and see what happens". Well, I did and I now see what happens.

If after reading my explanation of the circumstances, you still determine I owe the entire fine, I will pay it (hopefully with payment arrangements). I would only ask that you take into consideration that this was not done with any fraudulent intent or to avoid any payments. In fact, S. Clarke International somehow was sent intangible tax returns and I filled those out and paid whatever tax was due.

Thank you for your consideration in this matter. I look forward to hearing from you.
