I'm writing to you in regards to the attached letter received from the Division of Corporations following my attempt to register our home-based consulting business in Florida. In addition to the filing fees required, the letter includes notification of an unexpected penalty (\$2000) for failing to register our business promptly.

I am very sorry for this oversight. I was unaware that a specific registration application was required. I filed the company's 2001 corporate tax returns and believed that that was sufficient notice of the company's intent to do business in Florida. I did not realize that I had to notify the Division of Corporations separately.

We are a small "mom and pop" company that in the two years we've been in Florida has not even turned a profit. Paying a \$2000 fine poses a considerable hardship on the business. Clearly, we were not intending to defraud the state, as evidenced by the filing of our corporate returns. Our failure to register was accidental not deliberate. I respectfully request that under the circumstances you kindly consider waiving the penalty imposed.

I am in receipt of your letter granting BioVentures(BVI) a reduced penalty fee of \$500. I appreciate your kind consideration of our situation.

Upon further investigation into the statutes of the State of Florida, I have come to believe that even this penalty may not be warranted for the following reasons.

- 1. BVI, while located in Florida, has not conducted, nor does it have immediate plans to conduct business with any company located in the state of Florida.
- 2. BVI's business is interstate and international.
- 3. BVI's bank accounts are currently located in the state of Connecticut.

According to my reading of Title XXXVI, Chapter 607.1501 statutes, BVI has not begun to transact business in the state of Florida and therefore should not be subject to any penalty. If this interpretation is correct, then it was my error and I should have filled out item #6 on the "Application by a Foreign Corporation for Authorization to Transact Business in Florida" form to read "upon qualification" instead of putting in the date BVI relocated to Florida.
