We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation, adopt the following Articles of Incorporation for such corporation pursuant to the provisions of the District of Columbia Nonprofit Corporation Act:

FIRST: The name of the corporation is:

Alliance for Retired Americans

<u>SECOND</u>: The corporation is to have perpetual existence.

THIRD: The purposes for which the corporation is organized are to operate exclusively for the promotion of social welfare by promoting the common good and general welfare of the people of the United States, within the meaning of Section 501(c)(4) of the Internal Revenue Code. Such purposes include, but are not limited to, education, communication, and advocacy on issues of importance to older and retired workers and their families.

FOURTH: The corporation shall have members. Qualifications for membership shall be specified in the corporation's bylaws.

FIFTH: The corporation may exercise all power or authority granted to it under the District of Columbia Nonprofit Corporation Act or otherwise, including, but not limited to, the power to accept donations of money or property, and to own or lease property, whether real or personal.

SIXTH: In carrying out its purposes, the corporation shall not have or exercise any power or authority granted to it under the District of Columbia Nonprofit Corporation Act, or engage directly or indirectly in any activity, that would prevent it from qualifying as a corporation described in Section 501(c)(4) of the Internal Revenue Code.

SEVENTH: The corporation shall not participate or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office to an extent that would disqualify it from tax exemption under Section 501(c)(4) of the Internal Revenue Code.

EIGHTH: The Corporation shall not be operated for the primary purpose of carrying on a trade or business with the general public for profit.

NINTH: The affairs of the corporation shall be managed by a Board of Directors, which shall also be known as the Executive Board. Qualifications for membership on the Board of Directors shall be described in the bylaws. The number of members of the Board of Directors shall be fixed by the bylaws and may be increased or decreased from time to time as provided therein, but in no event shall the number of members be less than three. Each member of the Board shall be elected or appointed in the manner and for the term provided in the bylaws.

TENTH: Upon the termination, dissolution, or winding up of the corporation in any manner or for any reason, its assets, if any, remaining after payment (or provision for payment) of all liabilities of the corporation shall be distributed to, and only to, one or more charitable or social welfare organizations.

ELEVENTH: The number of members of the initial Board of Directors shall be three.

THIRTEENTH: Any reference in these Articles to any provision of the Internal Revenue Code shall be deemed to mean such provision as it now exists or is later amended or superseded, as the case may be.
