

The company's name is GOLD DRACON 8 INT'L, INC. and it was incorporated in New York on March 24, 2003. It has authority to do business in Florida as of October 17, 2003 but now wishes to withdraw that authority. Instead, it wants to file for incorporation in the State of Florida but desires to use the same name it used when it filed for the foreign business entity. Therefore, please process the withdrawal first and immediately proceed to the incorporation so that this company can retain the same name without having anyone else using it.
