I am writing to request a waiver of any fees or penalties associated with the late filing for qualification as a Foreign Corporation doing business in the state of Florida. I am the president of Food and Beverage Associates, Inc., a Georgia Corporation. This corporation does business in Georgia and, after relocating my domicile to Florida, also does business in Florida.

Starting in the calendar year 2000, I began to pay wages in Florida. I have made a good faith effort to file the necessary quarterly returns.
