

ARTICLE THREE - PURPOSES

The purposes for which the corporation is organized are:

- A. To transact any and all lawful business for which a corporation may be incorporated under the Texas Business Corporation Act.
- B. To engage in the business of buying, leasing, or otherwise acquiring, owning, holding, managing, developing and controlling personal property of every description, wherever situated, or any interest therein, including without limitation its own stock or stock in any other corporation and any interest of any kind in any partnership, limited partnership or joint venture, and selling, conveying, mortgaging, pledging, leasing, renting or otherwise disposing of such property, or any part thereof, or any interest therein.
- C. Subject to the provisions of Part Four of the Texas Miscellaneous Corporation Laws Act, to engage in the business of buying, leasing or otherwise acquiring, owning, holding, developing, managing and controlling real property of every description, wherever situated, or any interest therein, and subdividing, selling, conveying, mortgaging, leasing, renting, or otherwise disposing of such property, or any part thereof, or interest therein.
- D. To engage in the business of buying, selling, manufacturing, distributing, marketing and generally dealing in and with goods, wares and merchandise of every kind and nature
- E. To engage in the business of providing services of every description to any individual, corporation, group or agency, wherever situated.
- F. To borrow or raise money for any of the purposes of the corporation and from time to time, without limit as to the amount, to draw, make, accept, endorse and issue promissory notes, drafts, bills of exchange, warrants, bonds, debentures and other negotiable and non-negotiable instruments and evidence of indebtedness, and to secure the payment of any thereof and of the interest thereon by mortgage, pledge, security agreement and financing statement, or conveyance or assignment in trust of the whole or any part of the property of the corporation, whether at the time owned or thereafter acquired, and to sell, pledge or otherwise dispose of such bonds or other obligations of the corporation for its corporate purposes.
- G. In general to carry on any other business in connection with the foregoing and to have and exercise all the powers conferred by the laws of the State of Texas upon corporations formed under the Texas Business Corporation Act and to do any and all things hereinbefore set forth to the same extent as natural persons might or could do. Nothing in these stated purposes shall limit any general power conferred upon corporations by the Texas Business Corporation Act.
