

Dear Lee:

I am writing this letter in response to our conversation regarding Speedway Blues, Inc., ref #W03000036543. As I stated on the phone, between 7/1/1999 and 7/31/2000 Speedway Blues, Inc. had an administrative sales office at 224 Datura Street in West Palm Beach, FL which only solicited orders which were then sent to the home office in New Jersey where they were either accepted or declined. When I read section 607.1501 subsection 2-f, it stated this activity did not constitute transacting business within the meaning of subsection (1), therefore Speedway Blues, Inc. was not required to register as a foreign corporation.

At this time I am being sued in Florida as an individual for business transacted by Speedway Blues, Inc. In order to defend myself and for Speedway Blues, Inc. to defend itself, the company wants to be registered as a foreign corporation. In November of 2003, Speedway Blues, Inc. submitted an application to register as a foreign corporation with a certificate of good standing from the state of New Jersey.

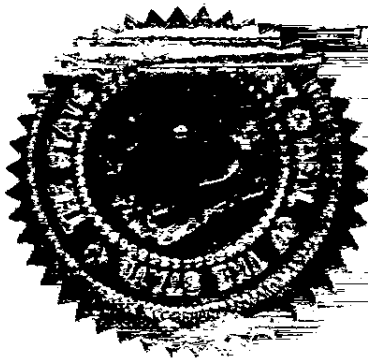
