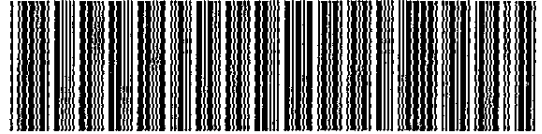

Reference is made to your letter to Patricia McCormick dated November 18, 2003, and to her earlier Transmittal Letter to you.

You retained my firm's check in the amount of \$78.75, and also the Certificate of Good Standing from the Commonwealth of Pennsylvania. The certificate of Good Standing is also known as a "Certificate of Existence."

I have prepared a revised Application By Foreign Corporation For Authorization To Transact Business in Florida, and enclose it herein. Please accept the said Application.

The earlier Application contained a mistake in that Patricia McCormick indicated that Self-Seal had started transacting business in Florida in 1990. That statement was incorrect.

Self-Seal merely solicits orders from ~~Pennsylvania~~ <sup>Florida.</sup> The orders are sent to Pennsylvania by mail, and must be accepted in Pennsylvania before they become contracts. Self-Seal has only one place of business, which is here in Bridgeport, Pennsylvania. Self-Seal has no staff or agent, or employee, or representative in Florida, or anywhere else, other than in Pennsylvania.

Therefore, I believe that Self-Seal satisfies §607.1501(2)(f) of the Florida Statutes.

I believe that the penalty referred to in your November 18, 2003 letter should be rescinded because the above-referenced statement was incorrect.

Please send me a Certificate of Status as soon as you have approved the Application.


