



The taxpayer above has received a notice dated October 28, 2003 (copy enclosed) stating that fees and penalties totaling \$5,750 are due.

This amount is based on the company's transacting business as of January 1, 1998 without submitting an "Application for Authority to Transact Business in Florida". We have enclosed a copy of the application that was filed. It indicates that activities began on June 23, 2000, rather than on January 1, 1998 as your letter suggests. On June 23, 2000 the Wisconsin taxpayer purchased residential rental property in Florida. The application was not filed at that time as we were not aware that rental activities constituted "transacting business".

The taxpayer filed Florida Corporate Income Tax returns for 2000, 2001 and 2002. These returns were filed on time and reported Florida taxable income (losses) in the following amounts:

2000 \$ (120,193) loss 2001 \$ (72,459) loss 2002 \$ 17,713 income

Based on the losses actually generated in Florida, we disagree with the proposed penalties which are not only excessive, but are calculated with incorrect information. The taxpayer has generated liftle Florida income and has reported it in good faith on the appropriate income tax returns.

We do agree that annual reports should have been filed for 2000-2002 and we have enclosed a check for \$450 for these years. Please apply this payment to their account, and process the application as previously filed.
