**IMPORTANT NOTICE REGARDING THE STATUS OF YOUR CORPORATION**

NOTE: THERE IS NO PROVISION TO PLACE A CORPORATION ON "INACTIVE STATUS" WITH THE DIVISION OF CORPORATIONS.
