This letter is written in response to your notice dated November 18, 2003 assessing annual report/uniform business report and penalty fees of \$5,750.00 on the above-referenced corporation doing business in the state of Florida. Per a telephone discussion with your office, we are writing to present the mitigating circumstances surrounding our recent registration within your state and the situations giving rise to our business presence, therein.

On September 30, 1999, Greif Bros. Corporation of Ohio, Inc. ("GBC OH") was formed and began business in the state of Ohio, its commercial domicile. Upon the advice of independent advisors, GBC OH was deemed to have a business presence within Florida and, as such, the recommendation was made that we file a tax return with the Department of Revenue. Independent third parties, pursuant to the recommendations of independent advisors on which those filings were based, handled the filing of tax returns. At no point in time were we prompted to or in any way lead to believe that we needed to file a registration statement with the Department of State within Florida.
