I am writing this letter in response to a recent notification and follow up letter from the State of Florida regarding our registration in Florida.

IP.com, Inc. was formed in the state of New York in March 2000 and began operations on May 5, 2000. When the Company began operations we had one employee in Florida and we later added another. During the first few months of the Company's operations we set about applying to do business in the various states where we had employees. We completed what we thought were all the necessary applications and filed them, including Florida.

In mid 2002, I read some articles on companies that had failed to file the necessary forms in various states and had incurred substantial penalties for failure to register. In order to ensure we were properly filed and registered in all of the states where we did business (and to make sure we did not accidentally miss anything) I engaged the Corporation Service Company (CSC) to contact each of our states and obtain a certificate of good standing. In July 2002, through CSC, I received the attached certificate from the State of Florida confirming, what appeared at the time to be, proper registration and filings.

A few months ago, I received notice from your office that we were not registered in Florida. At the time, I assumed that there was a filing that we had missed by accident and completed the forms that were sent. I then received your letter dated October 25, 2003 notifying me of changes that needed to be made to the form and also informing me that a penalty of \$5,750.00 was due as a result of our failure to file. Since I thought we were properly registered, I was very surprised by this penalty. As a next step, I examined the certificate of good standing that I received from your office last year. As you can see on the enclosed certificate, the name on the certificate is essentially the same, we are IP.com,

Inc. and the form is for IP-com, Inc. and the date of the filing, October 25, 2000, coincided with the time frame when we were filing in the various states. I realize now that the expression "organized under the laws of the State of Florida" should have been an indication that something was not right, but to the untrained eye (mine) I thought this meant the day that we were registered in Florida. Upon receiving and reviewing this certificate, I thought we were properly filed in Florida. From reading your recent letter, I now realize that there is a different company which was incorporated on October 25, 2000, named IP-com, Inc. and that this is not us.

Our lack of proper registration is not intentional and was done in error. We have tried to ensure that we were compliant in each of the states where we operate. As an example, we have filed tax returns in the State of Florida since 2000. I thought that we were properly registered in Florida, when it turned out we were not. I apologize for the oversight.

Due to the above circumstance, I am writing to you to respectfully request that any penalties associated with our lack of filing be waived. We are happy to pay the normal and recurring filing and/or registration fees.

I have also enclosed the completed registration form with corrections. I have also engaged CSC to act as our agent in Florida and I have completed the relevant information.

I would be happy to speak to someone about the above circumstances if necessary.
