### ARTICLES OF AMENDMENT OF

### THE ARTICLES OF INCORPORATION OF

## STRUCTURAL DESIGN GROUP LIMITED

(a Maryland corporation)

STRUCTURAL DESIGN GROUP LIMITED, a Maryland corporation, having its principal office in Montgomery County, Maryland (which is hereinafter called the "Corporation") hereby certifies to the State Department of Assessments and Taxation as follows:

FIRST: The Corporation desires to amend the Charter of the Corporation.

SECOND: The original Articles of Incorporation of the Corporation (the "Articles") were filed with the Maryland State Department of Assessments and Taxation on June 8, 1992.

THIRD: The Articles are hereby amended by striking in its entirety Section Numbered One (1) and by substituting the following in place thereof:

Washington Street, Suite 900, Rockville, Maryland 20850. Said Resident Agent is an individual over the age of 18, actually residing in the State of Maryland."

FIFTH: The foregoing amendment to the Charter of the Corporation has been advised by the Board of Directors and approved by the stockholders of the Corporation.
