We have been informed by your department that this application was not submitted. Since the company was incorporated in Delaware we were unaware that any further filing was necessary in Florida. The proper paperwork needed, a certificate of good standing, to complete this filing is being obtained from the State of Delaware. We hope to receive it next week...

We did not discover the need for further filing until December, 2003. It was brought to our attention by the Florida Department of Agriculture and Consumer Services when attempted to renew our Sellers of Travel license. We had been registered with the Department of Agriculture since December 5, 2001. A copy of that registration certificate is enclosed for your review. When we attempted to renew this license, the informed us for the first time that we were not a registered corporation authorized to conduct business in Florida.
