I am responding on behalf of the above-captioned corporation to your letter dated December 4, 2003 (copy enclosed) requesting payment of \$1,150.00 **** to cover both annual report/uniform business report and penalties fees***** to respectfully request abatement of these penalties.

As I mentioned during our phone call today, World Almanac Education Group, Inc. ("World Almanac" or the "Company") employs a sales representative who is a resident of Florida. The sales representative reports to the Company's headquarters located in New York City and is free to otherwise conduct her business activities in the location of her choice. World Almanac does not have a business location in Florida.

In the second half of 2003, my firm was engaged to review the business activities of World Almanac to assist it in complying with local tax laws. Given the Company's limited contacts, it was debatable whether or not a strict responsibility to register existed within Florida. However, World Almanac is conservative in matters of taxation and business registration and therefore decided to register to collect Florida sales taxes, and register to do business in Florida.

Based upon the aforementioned facts, I respectfully request you abate the penalty levied against the Company.
