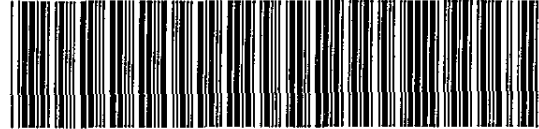



In response to your letter dated January 12, 2004, we are submitting this affidavit to correct an erroneous entry on our Application by Foreign Corporation for Authorization to Transact Business in Florida filing. **Line 6 of the application should have said "upon qualification"**. Instead the date that was entered was the date Katolight made its first sale into the State of Florida. Katolight has only solicited orders in the state. The orders are obtained through independent dealers who write up a purchase order and then submit the purchase order to Katolight's Mankato, MN office where the credit check, customer history, and other items are reviewed and analyzed before approving the order. All orders are required to be approved by the appropriate personnel in Mankato, Minnesota.

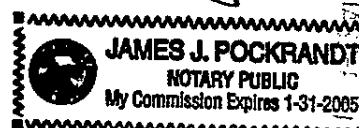
Under Florida Statute Section 607.1501 there are activities that do not constitute transacting business in Florida. These activities include selling through independent contractors and soliciting or obtaining orders from someone in Florida if the orders require acceptance outside of Florida before they become contracts.

Katolight's activities in Florida consist of obtaining orders through distributors and approving those orders in Minnesota. Katolight's activity has not changed, however, it does request to be authorized to transact business in Florida for 2004 and going forward. Katolight is requesting this authority to be able to use the Florida court and legal system to enforce collections on receivables that may go bad.



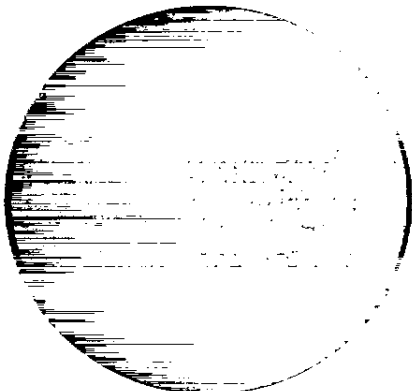
