To conduct regular classes, lecture-demonstrations, workshops, seminars, residences and other modes of instructional methods on Indian music and dance in New York.

To arrange for the supply of musical instruments and other related materials for students. This process may involve getting supplies from India, as most of the instruments are not made here.

To organize concerts of Indian music and dance with the purpose of promotion and preservation. This process may involve sponsoring qualified musicians and teachers to the benefit of both listeners and students.

To publish books, journals, newsletters or any other types of reading materials on music for the purpose of promotion and preservation. To publish audio and video recordings of music with the purpose of promotion and preservation.

To offer scholarships to talented students of music.

No part of the income of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

No part of the activities of the corporation shall be carry in on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal Government, or to a state or local government, for a public purpose.

This corporation is formed strictly for charitable purposes as mentioned above and no part of the income is to inure to the benefit of the members of the corporation.
