In reviewing the original paperwork submitted to the State of Florida under the SNAPS II Contract No. 2502415-1 (dated April 19, 2001), I find no reference to the requirement mentioned in your letter. The requirement for Fluke Networks to complete an Application by Foreign Corporation for Authorization to Transact Business in Florida was submitted to me in April of 2002.

Our Sales Engineer responsible for the State of Florida, Dave Bethune, held a meeting with the Department of Management Services in mid 2000. He was provided with the steps required to do business in the State of Florida by Ms. Gwen Baker, the current SNAPS II Administrator. We completed those steps and our application was approved by State Purchasing in April of 2001. In April of 2002, we submitted for a renewal of our agreement and were told that we had to register with the Department of State prior to the renewal of our SNAPS II Agreement. This was the first time that anyone informed us that we were required to register. We requested an application and upon receiving the application, it was completed in its entirety, an original certificate of existence was provided and the registration fee of \$70.00 accompanied the transmittal letter. It was then returned to the Registration Section, Division of Corporations, P.O. Box 6327, Tallahassee, FL, 32314.

In your letter dated January 8, 2003 you referenced a letter dated September 16, 2002. This letter was not received by us. We feel that we have done everything requested of us in order to do business within the State, but are very confused by this recent action by your office.
