

**We have received a letter in return for our Application by Foreign Corporation for Authorization to Transact Business in Florida stating that Ludy Greenhouse Mfg. Corp. was doing business before registering and therefore have penalties due.**

**Before the first job Ludy's did in Florida, I called and setup with the state to pay sales and use tax along with the corporate return that we file each year. This being done, I thought we did, and have been doing everything required by the state of Florida. After receiving this letter, I called and was told that this is a separate division in Florida. I am not sure what the difference is, but I suppose there is one.**

**I hand wrote the date that Ludy's registered on the top of the form to show when this was setup with the state. I had no idea that you were not connected to the state and knew we have been there on occasion.**

**I would like to stress that we registered with the state to do business and the state has been processing our returns, payments etc. and it was never brought to my attention that because Ludy is out of the state we are required to do more.**

**I can assure you the we had no idea when we registered to do business that there was a separate department to report to. I am requesting the charges be reviewed and removed from our account. This was not a deliberative action.**

**We pride ourselves on the fact that we always try to do what is right with the states we work in, even if it makes us less competitive in our market because our competition does not follow the same.**
