It was a pleasure to speak with you earlier today. I represent Marketing Group South, Inc. ("MGS"), an Alabama corporation that began doing business in Florida on or about November 1, 2003. MGS recently attempted to file the necessary documents to qualify to do business in Florida, but received a letter from you dated March 15, 2004, a copy of which is enclosed, which indicated that MGS owed Florida more than \$1,000 in fines for late qualification.

While ideally we understand MGS should have qualified to do business in Florida before it began such business in Florida, its delay in doing so was relatively short, only a few months. As a result, it seems as though the \$1,000 fine is quite excessive for such a short period of time.

It is our understanding that it is possible to have this fine waived, either in whole or in part. We request that since MGS voluntarily submitted itself for qualification only a few months after it was required to do so, that the fine be waived and MGS be qualified in Florida for the regular qualification fee and any annual report/uniform business report fees that might be due.
