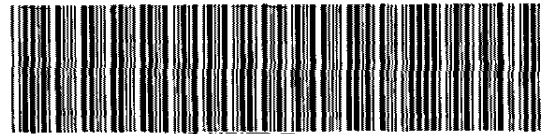



Since the year 2001 and there after our organization was totally inactive.


We did not own property nor pay rent for any facility.
