As accountants for the above-named taxpayer, we are responding to your letter dated December 30, 2003 (copy enclosed).

The letter is assessing penalties of \$5,750 against Premium Retail Services, Inc. for doing business in the State of Florida prior to submitting an "Application for Authority to Transact Business in Florida." The Florida Department of Revenue records show Premium Retail Services, Inc. has been transacting business in Florida since 1998.

Premium Retail Services, Inc. changed accountants during the course of business and, unfortunately, this oversight was not caught until the application was filed in November 2003.

Premium Retail has a history of timely filing all required federal and state income tax returns and paying all tax liabilities in a timely manner. We did not intentionally disregard the filing requirement to submit an "Application for Authority to Transact Business in Florida." As soon as we discovered this oversight, we immediately moved to correct the issue in 2003.

Given the facts that: (1) Premium Retail Services, Inc. had an internal change regarding their accountant, (2) Premium Retail Services, Inc. has a compliant history with all federal and state filing requirements, and (3) the unintentional oversight related to the application, which was immediately corrected upon discovery, we respectfully request the penalties be abated and the "Application for Authority to Transact Business in Florida" submitted November 2003 be processed.
