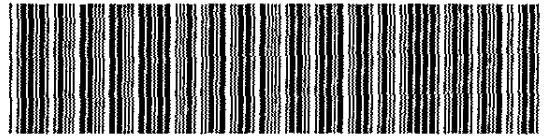

Dear Ms Brumbley,

I am writing regarding letter Number: 304A00023013. According to that letter it states that if Kris' Camp wants to do business in the state of Florida we need to pay a \$1000 penalty. After speaking with you on the phone I reviewed at the Florida Statutes where it states whether or not entities are required to file. It is my understanding from reading this that we were not required to file if it was not a 'repeated, ongoing transaction of similar nature'.

Kris' Camp is a small 501c3 incorporated in the state of California. We are a therapy intensive/respite camp for children with autism and their families. We have run programs in California for the last 10 years, and since my husband's job relocated us to Tallahassee we contemplated starting programs here in FL. In 2001 we applied for doing business in Florida, but then withdrew it as 1. We were erroneously filed as for profit. And 2. We did not end up holding a camp in 2002, and were getting a \$120 bill for filing fees for a for profit. As we try and conserve as much of our resources as possible for family scholarships, I thought we should just withdraw until we knew we would proceed.

As we were unsure of whether a program would happen, and after reading the statutes it was understood that you are not required to file if you are completing your activity within 30 days and it is not one of a series of repeated transactions, we did not apply until we knew we were proceeding with our 2nd camp. In 2003 we held a 4-day session of camp, which was completed well before 30 days transpired. We assumed that if it was

successful and we were going to proceed with an additional camp the following year, then we would apply (which is what we did).

I am not at all sure that we are required to file, as we will only be holding 5-day sessions once a year or every other year. I am not sure that this falls under repeated, ongoing transactions. To be sure though we went ahead and applied before holding our first repeated camp (June 2004 is the date we set).

If we are required to pay a penalty of \$1000, we will be unable to go forward with providing the families of Florida with this program. As our total Budget for Florida was \$5,000, it makes more sense to use that money toward scholarships in our AZ or CA programs.

I further request a face to face appeal if this letter does not resolve the \$1000 penalty.

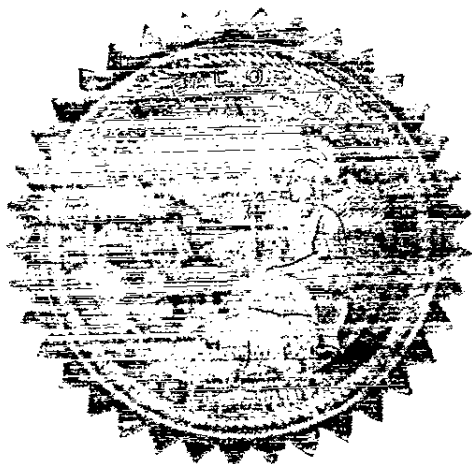
