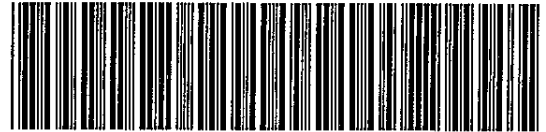

Dear Ms. Cline:

I am in receipt of your letters (copies enclosed) of May 10 concerning the captioned matters. I spoke to you by phone on May 17 to discuss the circumstances of these applications, with the hope that the civil penalties could be abated to some degree. You replied you had no authority in that area, but invited me to write a letter explaining my clients' position and you would forward it to your General Counsel's Office for consideration.

This letter then will set forth my clients' position with regard to imposition of the civil penalties.

Both EWA Government Systems, Inc. ("GSI") and EWA Information and Infrastructure Technologies, Inc. ("IIT") are Delaware corporations and wholly owned subsidiaries of Electronic Warfare Associates, Inc. ("EWA"), a Virginia corporation that qualified to do business in Florida on March 2, 1982 (Florida Document No. 852053). Prior to their incorporations, both GSI and IIT were unincorporated divisions of EWA, operating in Florida as part of EWA's authorization to do business there.

Upon and after GSI's incorporation in Delaware on January 22, 2002, nothing about EWA's/GSI's operations in Florida changed. EWA's offices in Florida remained (and currently remain) in EWA's name alone as tenant. Annual Reports and filing fees, unemployment taxes, intangible personal property taxes and other state and local taxes continued to be filed and paid by EWA. GSI apparently has filed its own Florida corporate income tax returns since 2002, but EWA actually paid the taxes. GSI merely continued the operations of EWA in Florida after its incorporation in 2002. All revenues are deposited into one bank account (in the name of EWA), but are credited to EWA's subsidiaries in its internal bookkeeping accounts.

The same analysis essentially holds true as regards the EWA/IIT relationship. Like GSI, IIT also evolved from the parent company, EWA, and was an operating division of EWA prior to its incorporation in 1997. The only significant difference between IIT's situation and that of GSI is that IIT has operated in Florida since 1998, whereas GSI was not created until 2002.


The January 22, 2002 Florida business commencement date on GSI's application (item number 6) was inserted for lack of any clear cut alternative. It was the date of GSI's incorporation in Delaware. I can guarantee you that on that date GSI did not actually do business in Florida. What I cannot do is pinpoint the date GSI actually did commence its business there. The lack of a clear line of demarcation between GSI and its parent, EWA, continues even through today.

The impetus to have EWA's subsidiaries obtain authorization to do business in Florida as foreign corporations came from EWA's accountants, who have been frustrated in trying to file various returns and reports in Florida and elsewhere for EWA's subsidiaries. Since Florida had no record of the subsidiaries' existence, it kept rejecting the subsidiaries' returns and reports. EWA personnel merely assumed (incorrectly) that since EWA was qualified in Florida, its subsidiaries did not need to qualify as well.

Given the foregoing circumstances, we would hope that the civil penalties imposed on GSI (\$2,300) and IIT (\$6,900) could be waived or abated in whole or in part by Florida.



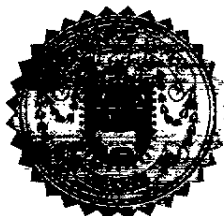
