We are Florida counsel for National Optronics, Incorporated (the "Company") which forwarded to us your letter dated May 10, 2004 (copy enclosed). The Company has requested that we correspond with your office to request an abatement of the \$1,000 per year civil penalty for its inadvertent failure to qualify to do business in Florida since 1998.

The Company has been present in Florida since some time in the mid-1980s, and has been properly registered with the Florida Department of Revenue ("DOR") as a dealer for sales and use tax purposes. In fact, the Company has been twice audited by the DOR with respect to sales and use tax liabilities. During neither of those audits was the Company ever informed by the DOR that it needed to be registered as well with the Department of State. The Company believed that, by registering with DOR as a dealer for sales and use tax purposes, it had properly registered in Florida for all purposes, including the authority to transact business.

The reason why the Taxpayer was subject to Florida nexus was that it had an employee present in Florida from June 14, 1993 through September 4, 2001. The Taxpayer has not had an employee resident in Florida since that time, although it does have employees who periodically come into Florida for the performance of installation and/or maintenance services.

The Company does not disagree that it should have registered to transact business in Florida with the Department of State. However, it honestly believed that its registration with the

DOR for sales and use tax purposes satisfied all of its registration obligations for Florida, and the Company was clearly not hiding its on-going business activities in Florida. Accordingly, it is requested that the Department of State abate the proposed civil penalties and require the Company to pay only the fees and costs which otherwise would have been imposed upon it had it properly registered with the Department of State.
