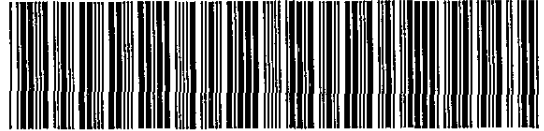

As accountants for the above named taxpayer, Imagemaster, Inc., I am writing you in response to a notice received from dated April 2, 2004 concerning Imagemaster, Inc. The notice outlines a reason for a penalty that is being charged by the State for doing business in Florida prior to receiving the authorization to conduct business in Florida.

Imagemaster, Inc. was formed and began business on January 1, 2003. Its customers in Florida require that the company be a registered business in the State of Florida. As such, the application to conduct business in Florida was completed and mailed to the State subsequent to January 1, 2003. Although the registration was completed after the business began, Imagemaster has yet to "conduct business" in Florida, all operations are in Michigan. The Company does not have employees in the State, it does not lease space, own property or inventory, or had any employees enter the State for business purposes since business began. The Company's only connection with Florida is the shipment of tangible personal property to customers in the State. The date used on the application was an arbitrary date chosen to complete the application.

Based on the facts mentioned above, I respectfully request that you waive the \$1,150 penalty assessed in the notice dated April 2, 2004. I appreciate your attention to this matter and if you have any further questions, please call me at (734)-302-6911.

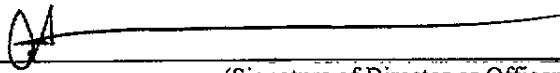

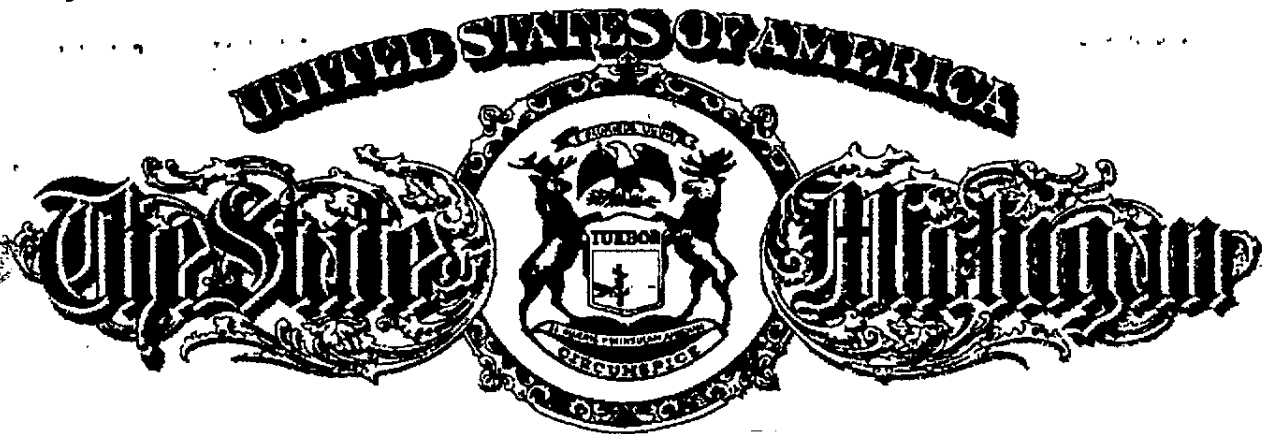
