

This is in response to your letter dated May 21, 2004 to David Walter Norris of our law firm's Chicago office regarding the American Radiological Nurses Association, Inc. (ARNA). Enclosed is a check for three hundred dollars (\$300) covering the annual report/uniform business report fees mentioned in your letter.

We respectfully request that the two thousand dollars (\$2,000) in penalty fees be abated in their entirety. I am the attorney principally responsible for representation of ARNA. I changed law firms late last year. Early last year, while at my former firm, I had assigned an associate attorney to file ARNA's Application for Authorization to Conduct Its Affairs in Florida. It was only recently that I learned that the Florida filing had not been accomplished. ARNA actually learned this when its management in Florida inquired regarding ARNA's annual reporting obligations and learned that ARNA had not been qualified to conduct business in Florida. When this was brought to my attention, I instructed Mr. Norris of my new firm to prepare the required filings.

ARNA is a small, nonprofit, tax-exempt organization representing dedicated professionals. Paying a \$2,000 penalty would constitute a true hardship and burden for the association. Notwithstanding that we strongly believe that abatement of the entire \$2,000 penalty fee is warranted and equitable, I note that section 617.1502(4) of the Florida Statutes provides for a "civil penalty of not less than \$500 or more than \$1,000 for each year." If the \$2,000 penalty cannot be abated in its entirety, we request that it be reduced to \$1,000.
