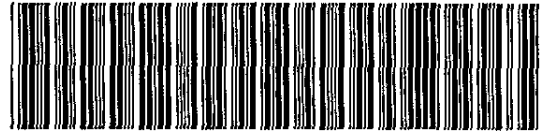

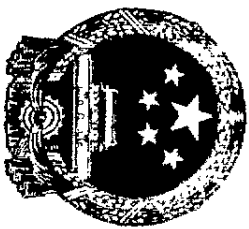

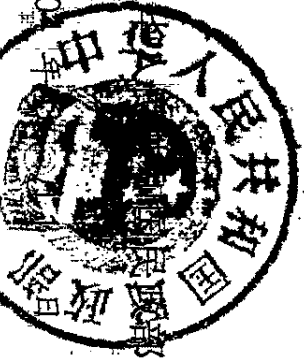

# **CONSTITUTION OF CHINA WOMEN'S DEVELOPMENT FOUNDATION**

## **Chapter I General Stipulation**

1. The name of the organization shall be China Women's Development Foundation(CWDF); hereinafter referred to as the Association.
2. The Foundation is an independent legal entity approved by the Bank of China and registered with the Ministry of Civil Affairs. It solicits and receives funds and material supports from individuals, entrepreneurs and organizations to facilitate the development of women and women's issues.
3. Objectives: The Foundation shall abide by the Constitution, law, regulations and policies of China. It shall dedicate itself to enhance the quality of women; to protect their legal rights and interests; and to uphold society to create a favorable environment for women's growth, enabling them to contribute to our overall economic and social progress, and to world peace.
4. The Foundation shall function under the guidance of the Chinese Women's Federation, and in conformity with the stipulations of the Bank of China and the Ministry of Civil Affairs.
5. The address of the Foundation shall be: 15, Jianguomennei Street, Beijing.

## **Chapter II Tasks**

6. To conduct educational training and consultative programs for improving the quality of women.
7. To protect the legal rights and interests of women; to facilitate their livelihood and personal growth; to promote employment; to enhance physical and mental health; and to foster general welfare.
8. To run tailor-made programs of economic development for ethnic minority women and those living in remote and poor areas; and to assist women in rural areas as they attempt to better economic conditions with the use of science and technology.
9. To award honors to those distinguished women who have made valuable contributions in our country's construction of socialist culture and material well being.
10. To actively promote communication and cooperation with compatriots in Hong Kong, Macau and Taiwan, overseas Chinese, international friends and organizations and women's organizations all over the world.

## **Chapter III Funds**

11. Sources of funds:
  - i. Donations from individuals, entrepreneurs and social organizations in China and overseas.
  - ii. Income from such services and capital appreciation permitted under government policy.
  - iii. Bank interests.
  - iv. Other legal income.
12. Uses of funds:
  - i. Income accrued from capital appreciation shall be used for expenses incurred in fund-raising and such functions as specified on Chapter II.
  - ii. Donations shall be used in accordance with the purpose, designation and methods expressed by donors, and in compliance with the law.
13. Management and supervision:
  - i. Under a clearly defined system of financial management, the Foundation guarantees that all accounting procedures are legal, true, accurate and comprehensive.
  - ii. Professional accountants shall handle all accounts under audit and supervision. The official accountant shall not perform any cash function. She shall, before any job-transfer or resignation, clear all accounts with her successor.
  - iii. Funds shall be managed in accordance with the financial control system of China, and monitored by the Board of Directors and the Bank of China. A report of detailed transactions shall be issued publicly at an appropriate time.
  - iv. Before a change of Board of Directors or the legal person, the financial situation of the Foundation shall be audited by the Chinese Women's Federation and the Ministry of Civil Affairs.
  - v. No individual or group shall manipulate, embezzle or misappropriate the Foundation's funds and assets.

## **Chapter IV Organization and Function**

14. The Board of Directors shall be the supreme governing body of the Foundation. It comprises the President, vice-presidents, the Standing Committee, the Secretary General and Directors. The term of office of Directors shall be three years. The Board shall meet once a year. Both additional or extraordinary meetings may be called when special circumstances demand.
15. There shall be a President and a number of vice-presidents elected from among the Directors. The President shall chair all meetings of the Board, and endorse major documents.
16. A Secretary General shall be appointed bearing the role of the

Foundation's legal person. She shall be responsible for overseeing the daily operations of the Foundation and shall not assume the role of legal person for any other organization.

17. The responsibilities of Directors shall be:

- i. To establish the Constitution for the Foundation, and to introduce amendments when appropriate.
- ii. To receive and review the annual plans and reports of the Foundation, and to monitor the use of funds.
- iii. To elect the President and vice-presidents, members of the Standing Committee, and the Secretary General.
- iv. To confer honors, such as Honorary vice-president, Life Honorary Director, Honorary Director and Honorary Adviser, to individuals in China and overseas who have made significant contributions to Foundation affairs.
- v. To recognize and give awards to individuals who have made outstanding contributions to further the cause of women and children.
- vi. To resolve on matters of importance, including the dissolution of the Foundation.

18. The rights and obligations of Directors shall be :

- i. To monitor and supervise daily operations, and to make constructive suggestions for action.
- ii. To implement the decisions of the Board following the stipulation of the Constitution.
- iii. To participate in all meetings and activities of the Foundation, and to ensure that the objectives and goals are reached.
- iv. To safeguard the legal rights and interests of women, and to reflect their needs and aspirations.

19. The Board of Directors shall elect members to form a Standing Committee to take care of ongoing businesses.

20. The responsibilities of the Secretary General shall be:

- i. To maintain the effective functioning of the office; to organize and carry out the annual plan of the Funds; and to report to the Standing Committee and the Board of Directors on a regular basis .
- ii. To recommend the Vice-Secretary General for appointment and to maintain a team of workers and volunteers to serve the Foundation.
- iii. To take care of any other business.

21. The Board of Directors shall establish an administrative office for the Foundation.

22. The salary scheme and benefits of all full-time officers shall follow that of government employees.
