I am in receipt of your correspondence of May 10, 2004. You have indicated that Liberty Growers, Inc. is being assessed a civil penalty of \$1,000 pursuant to Florida law for having failed to file the proper documentation in a timely manner to conduct business in the State of Florida.

I realize in most cases ignorance of the law is no excuse, but I would like to ask for a full or partial waiver of this penalty. When I arrived in Florida in 2003 I had asked my former CPA to make sure I was in compliance in Florida, and assumed he would take care of everything for me. The main reason business people hire CPA's and lawyers is to keep them in compliance with the law, and therefore out of trouble.

As my fiscal year end of April 30th was approaching I engaged another CPA. I try to conduct my business affairs properly and never intended to skirt my responsibilities. I'll make sure such an oversight does not happen again. Thank you for your time and understanding.
