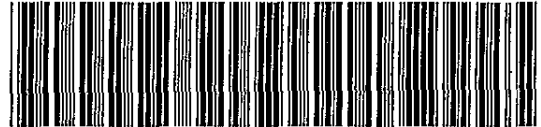


Dear Mr. Brumbley:
