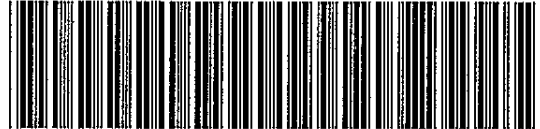

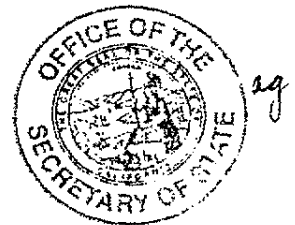

“ The name of the corporation is First American Realty Capital Corp.”

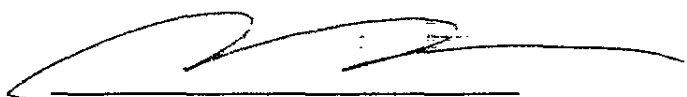
3. The foregoing amendment of Articles of Incorporation has been duly approved by the board of directors.
