Reference is made to your recent letter requesting approval to register the above-referenced fictitious name with the Florida Secretary of State by Bank OZK which is a FDIC regulated state chartered bank located in Little Rock, Arkansas.

Section 655.922, Florida Statutes, exempts a financial institution, holding company or its subsidiaries from the prohibition of using the word "bank," "banco," "banque," "banker," "banking," "trust company," "savings and loan association," "savings bank," or "credit union," or words of similar import, in any context or in any manner in its corporate name. Therefore, this Office will not object to the use of the above referenced name being registered to transact business in the state of Florida. However, this correspondence is not intended to grant the authority to act in any licensed capacity until all licensing requirements have been met within this state.

The undersigned George G. Gleason, as Chairman of the Board, and Helen W. Brown, as Secretary, respectively, of Bank of the Ozarks (the "Bank"), of Little Rock, Arkansas, certify that at the annual meeting of the stockholders of said bank held on the 7th day of May, 2018, paragraph (a) of Article I of the Amended and Restated Articles of Incorporation of the Bank was amended in its entirety to read as follows:

(a) The name of the Bank is Bank OZK, effective July 16, 2018.

The number of shares outstanding on the record date of the stockholders' meeting and entitled to vote on the adoption of the charter amendment was 128,595,345, and the number of shares outstanding on the date of said meeting was 128,614,971. The number of shares whose owners were present in person or by proxy at said meeting was 114,375,279. The owners of 112,927,783 shares who were present or represented by proxy at said meeting voted for the adoption of said charter amendment.

On February 26, 2018, the Board of Directors of said bank adopted a resolution providing that at the annual meeting to be held on May 7, 2018, a proposal to amend paragraph (a) of Article I of the Amended and Restated Articles of Incorporation to read as above set out would be submitted to all stockholders present or represented at said annual meeting. On or about March 15, 2018, notice and a description of the proposal was mailed by first class mail to each stockholder of the bank at the address of such stockholder as shown on the books of the bank.
