

This Merger Agreement is dated effective December 31, 2009 (regardless of when signed), by and between LEVY TIMBERLANDS, LLC, a Florida limited liability company, and LUCKY WARRIOR FARM & RANCH, INC., a Minnesota corporation,

WHEREAS, LEVY TIMBERLANDS, LLC, ("Levy Timberland") is a limited liability company organized and existing under the laws of the State of Florida, and

WHEREAS, LUCKY WARRIOR FARM & RANCH, INC., ("Lucky Warrior") is a corporation organized and existing under the law of the State of Minnesota, and is duly authorized to transact business in the State of Florida, and

WHEREAS, the Levy Timberland and Lucky Warrior desire for Levy Timberland to merge into Lucky Warrior in accordance with Sections 608.4382, through 608.4383, Florida Statutes, and Minnesota Statutes, Chapter 322B, with Lucky Warrior becoming the surviving company, and

WHEREAS, the merger has been approved by both Levy Timberland and Lucky Warrior in accordance with the applicable laws of the state or jurisdiction under which such entities are formed, organized or incorporated.
