

ATTESTATION

The Undersigned Secretary General of the Secretariat of State in the Offices of Government and Justice, certifies the Resolution that literally says: "RESOLUTION NO. 2343-2003.- THE SECRETARY OF STATE IN THE OFFICES OF GOVERNMENT AND JUSTICE. Tegucigalpa, Municipality of the Central District, on the sixth day of August of the year two thousand and three. CONSIDERING for resolution the petition submitted to the Executive Power through the Secretariat of State in the Offices of Government and Justice, on the eighth day of April of the year two thousand and three by the lawyer RAUL LOPEZ RIVERA, in his character of Legal Representative of the "FUNDACION APADRINE UN ARBOL (FUNDARBOL)" [SPONSOR A TREE Foundation], with domicile in the city of Tegucigalpa, Municipality of the Central District, entered into to request the Juridical Personality and approval of its Articles of Association, WHEREAS: The petitioner accompanied its request with the corresponding documentation, WHEREAS: the request was given the legal processing, ordering to hear the opinion of THE SECRETARIAT OF STATE IN THE OFFICES OF NATURAL RESOURCES AND ENVIRONMENT and of its Legal Department, whom issued favorable opinions. WHEREAS the "FUNDACION APADRINE UN ARBOL (FUNDARBOL)" paid to the State of Honduras the amount of Fifteen Thousand Lempiras (Lempiras 15,000.00) in accordance with the stipulations contained in numeral 22 of the Ministerial Agreement No. 618-2002, dated on June 17, 2002, as evidenced with the receipt for payment No. 570345, dated April 4, 2002. CONSIDERING: That the "FUNDACION APADRINE UN ARBOL (FUNDARBOL)" is created as a civil association of mutual benefit, whose statutory regulations do not contradict the country's laws, the public order or moral conventions, therefore it is admissible to concede what has been requested. CONSIDERING: That the President of the Republic issued the Executive Decree No. 002-2002, dated January twenty eight of the year two thousand and two, through which he delegates to the Secretary of State in the Offices of Government and Justice the specific competence to issue this administrative act, according to Articles 11, 16, 116, 117 and 119 of the stipulations of the Public Administration General Law,

Articles 4 and 5 of the Administrative Procedures Law. THEREFORE: THE SECRETARY OF STATE IN THE OFFICES OF GOVERNMENT AND JUSTICE, in use of the constitutional attribution established in Article 245, numeral 40 of the Constitution of the Republic, and in application of ARTICLES 29, reformed through decrees 06-98, 116 and 120 of the Public Administration General Law, 44 numeral 6 of the PCM-008 Decree on the Executive Power Organization, Functioning and Competence Regulations. RESOLVES: FIRST: To grant the Juridical Personality to the "FUNDACION APADRINE UN ARBOL (FUNDARBOL)", domiciled in the city of Tegucigalpa, Municipality of the Central District and to approve its Articles of Association, as follows: Statutes of the "FUNDACION APADRINE UN ARBOL" (FUNDARBOL). CHAPTER 1. INTRODUCTION. ARTICLE 1.- The "FUNDACION APADRINE UN ARBOL" is hereby created as a private, non-for-profit, strictly apolitical institution, of undefined duration and patrimony of its own, whose domicile shall be Tegucigalpa, Municipality of the Central District, hereinafter to be acknowledged as FUNDARBOL, and that shall be governed by these statutes. ARTICLE 2.- The "FUNDACION APADRINE UN ARBOL" has as its own fundamental principle what has been said by the Organization of American States in its Inter-American Action Program for the Environment Preservation, that "Every person has the fundamental right to live in a propitious environment, to live a dignified life, and to enjoy health and well-being." ARTICLE 3.- The "FUNDACION APADRINE UN ARBOL" shall have the following ends: a) To implement, orient and apply every FUNDARBOL activity to protect, develop and solve the problems related with the Honduras ecological needs and the well-being of the population, according to the Constitution of the Republic, its laws and regulations and in accordance with the guidelines established through the country's specialized institutions. b) To implement, apply and promote agricultural and forestry activities and practices to extend the coverage and the environmental beneficial functions of the integral forestry re-population policies in force. c) To promote sustainable agricultural, forestry development and pragmatic environmental education in the areas and/or laboratories under the jurisdiction of the national ethnic groups. d) To establish and coordinate at the community councils and cooperative associations

level, custody units to protect the re-forested woods. e) To promote practical environmental education programs at the community Primary School level; and, f) Any other form of cooperation oriented to the progressive well-being of Hondurans.

CHAPTER II. ON THE MEMBERS: ARTICLE 4.- The members of the Foundation shall be the natural or juridical persons that at the time of its foundation subscribed the Incorporation Act and those latter proposed by the Board of Directors. The Foundation members shall have the same rights and obligations. There shall be the following types of members: A. HONORARY MEMBERS: Outstanding citizens that because of their merits may be proposed to be members for a pre-established time of one, three, five or more years or for life, without any type of obligation as for attendance, quotas and others. B. COLLABORATING OR CONTRIBUTING MEMBERS: Are those that for their contributions to FUNDARBOL, either in cash or in goods or service, may be appointed for a year and who may be requested attendance, quotas and other FUNDARBOL obligations. After three years of being contributing members, they may, by common consent, be requested attendance, quotas and all other FUNDARBOL obligations. After three years of being contributing members, they may be considered by common consent to be proposed as new members. C. NEW MEMBERS. Are people with a relevant curriculum who may be asked by the Board of Directors to participate as partners, with all the founder partners rights and obligations. D. YOUNG PARTNERS: Are children or youngsters, under legal age, that with board of directors, plans and projects of their own may integrate as FUNDARBOL associates in its projection towards the future generations, establishing the attendance, quotas and other obligations for their own organization. **CHAPTER III. ON THE ORGANIZATION.**

ARTICLE 5.- The "SPONSOR A TREE" Foundation shall be ruled by the following organs: a) the General Assembly. b) The Board of Directors. The Board of Directors may appoint an Executive Director to act, in effect, as FUNDARBOL's manager, with administrative responsibilities, who could attend the Board of Directors Meetings with voice, but without voting rights. **CHAPTER IV. ON THE GENERAL ASSEMBLY. ARTICLE 6.-** The General Assembly is the Foundation's supreme organ and as such, it represents its maximum authority. It shall be

formed by all the founder partners and by all other natural or juridical persons incorporated according to these Statutes. (NEW PARTNER AND CONTRIBUTING PARTNERS). **ARTICLE 7.-** The Assemblies shall be Ordinary and Extraordinary. The Ordinary Assembly shall meet twice a year; the first meeting to be held on the first fortnight of June and the second on the first fortnight of December. The extraordinary Assembly shall be held when deemed convenient and it shall be convoked by the Board of Directors or by twenty percent (20%) of the members not having outstanding accounts with FUNDARBOL. The Extraordinary Assembly shall only deal with the subjects for which it was expressly convoked. **ARTICLE 8.-** The General Ordinary Assembly shall have the following attributions: a) To approve the Internal Regulations, or to modify them. b) To Establish the Foundation general policy. c) To know, discuss, approve, modify or disapprove the Board of Directors annual report. d) To know, discuss, approve, modify or disapprove the Work Plan for the following year at the December Assembly. e) To know the Foundation financial statements. f) To elect the Board of Directors members, when appropriate g) To appoint the EXECUTIVE DIRECTOR that would act, in fact, as FUNDARBOL Manager. h) To formulate the REGULATIONS ON THE EXECUTIVE DIRECTOR ATTRIBUTIONS AND RESPONSIBILITIES and any other regulation required for the institution well functioning. **ARTICLE 9.-** The legal quorum required to hold the Ordinary and Extraordinary Assemblies at the first call shall be a half plus one of the members being up to date in their accounts with FUNDARBOL and, in a second convening, with any number of attending members. In a second convening, the meeting may be held two (2) hours after the first call, having both convening to be announced in the same notice. **ARTICLE 10.-** The convening to General Assemblies shall be made by the Board of Directors thorough the Secretary, as follows: a) By a written notification sent to every one of the members to their latest address the Foundation has. Each member should maintain the FUNDARBOL Secretariat informed to this respect. b) By at least two (2) publications in a newspaper of national circulation, at least fifteen calendar days in advance to the date of the Assembly, and on its absence, through an invitation list in which they sign as understood. **ARTICLE 11.-** The resolutions adopted by

duly convoked and legally constituted Assemblies shall be valid when they are made and approved by the simple majority of votes of the attending members. Each member shall have right to one vote. In case of a tie, the President shall have a quality vote. In case a member is not able to attend, he could be represented by another member, who should submit and deliver a written evidence of such representation to the Secretary of the Assembly, who, in turn, should place it in the corresponding file.

CHAPTER V. ON THE BOARD OF DIRECTORS.

ARTICLE 12.- The Board of Directors is the executive organ in charge of the Foundation Direction, Administration, Organization and Government. It shall be formed by twelve (12) members, as follows: A President, a Vice-President, a Treasurer, a Vice-Treasurer, a Secretary, a Vice-Secretary, a Supervisor and five (5) members.

ARTICLE 13.- To be a member of the Board of Directors the conditions of being an active member of the Foundation, of acknowledged good behavior, moral solvency and acknowledged honesty are required.

ARTICLE 14.- The Foundation legal representation corresponds to the Board of Directors and it shall be exerted through the President.

ARTICLE 15.- The Board of Directors shall be elected for two-year periods by majority votes in an Ordinary General Assembly. Once they have been sworn, the members shall take office at the same act and can be re-elected.

ARTICLE 16.- The Board of Directors shall meet at least once a month and could meet as many times as necessary for the full compliance of its functions. The meeting shall be called by the President, either directly or through the Secretary, by written, verbal, telephone, fax communication, or through any other way that could be more expedite for its members.

ARTICLE 17.- The quorum for the Board of Directors meetings shall be formed by four (4) of its members, having the President to be present and, on his absence, he should delegate the presidency in writing to an associate who is up to date with his fees and the decisions shall be adopted by the simple majority of votes of those members present. No more than one meeting could be held with the same participants, and at the next Board of Directors meeting a minimum of six Board of Directors members should be present. In case of a tie, the President or his representative should have a quality vote.

ARTICLE 18.- The Board of Directors attributions shall

be: a) To draw up FUNDARBOL policies and to establish priorities in search of its objectives. b) To issue the procedures for application of the Foundation general policy. c) To orient, direct and implement FUNDARBOL operations in accordance with its objectives. d) To issue the Regulations and/or the internal and external norms it deems convenient for the Foundation government, administration, organization and functioning. e) To prepare the annual work plan and to submit it for the General Assembly consideration. f) To prepare the annual report and the corresponding memoir and to submit them for the General Assembly consideration. g) To approve the admission of new members, as well as their exclusion by lack of compliance of their obligations, or by any other justified reason. h) To establish and to integrate the committees, commissions, working groups and other subordinate groups it deems convenient for the compliance of FUNDARBOL objectives, appointing executive secretaries and/or special secretaries for them, indicating their corresponding attributions and obligations. Likewise, it shall contract the necessary personnel deemed for the implementation of FUNDARBOL ends. i) To solve about the purchase, sale, exchange, alienation, or lien of FUNDARBOL property. j) To solve about the contracting of loans and obligations of any nature and to establish the mandatory fees for the associates. k) To solve the acceptance or rejection of conditioned donations or contributions. l) to exert the attributions contained in the preceding articles i), j), and k), the Board of Directors should require de General Assembly's approval. **CHAPTER VI. ATTRIBUTIONS OF THE BOARD OF DIRECTORS MEMBERS. ARTICLE 19.- ON THE PRESIDENT.** The President attributions are: a) To be the Foundation Legal Representative with ample faculties. b) To convoke, either directly or through the Secretary, the Board of Directors meetings and to preside them. c) To convene, either directly or through the Secretary, to Ordinary and Extraordinary General Assemblies, when the Board of Directors meetings called for to that end are not held because of insufficient quorum. d) To watch for the implementation of the Assemblies and the Board of Directors agreements and resolutions. e) To jointly authorize and sign with the Treasurer the expenses incurred by FUNDARBOL. f) All other attributions that the General Assemblies or the Board of Directors commission it or that correspond to

TRANSLATION

it, according to these Statutes. **ARTICLE 20.- ON THE VICE-PRESIDENT.** The Vice-President shall assist the President in the performance of his functions and shall replace him in case of absence or temporary or definitive disability until his re-incorporation or at the end of the period for which he was elected. **ARTICLE 21.- ON THE SECRETARY.** The Secretary is the official conduit and means of communication of the General Assemblies and of the Board of Directors and shall have the following attributions: a) To receive, answer and dispatch the communications relating to the General Assemblies and the Board of Directors. b) To keep the General Assembly and the Board of Director minute books. c) With the President or the corresponding member instructions, to convoke to Ordinary and Extraordinary General Assemblies. d) Other missions assigned to him. **ARTICLE 22.-** On the Secretary's absence such functions shall be performed by the Pro-Secretary, who shall replace him in case of a temporary or definitive absence. On the Pro-Secretary's absence, the members, in their order, shall assume this responsibility. **ARTICLE 23.- ON THE TREASURER.** The Treasurer attributions are: a) to manage the FUNDARBOL goods under his responsibility. b) To collect and/or to receive from the members, contributing persons, or from national or international public or private institutions, the values that are contributed, granted, donated or transferred to the Foundation. c) To make duly authorized payments and withdrawal of funds, signing the corresponding voucher and/or documentation jointly with the President or with the Person he designates. d) To keep the accounting records legally and operationally necessary and to submit the corresponding annual reports, or when required. **ARTICLE 24.-** On the Treasurer's absence the Vice-Treasurer shall perform his functions and shall replace him in case of a temporary or definitive absence. On the Vice-Treasurer's absence, the Board of Directors shall select one of the Board of Director's members to assume these functions. **ARTICLE 25.- ON THE SUPEVISOR.** The Supervisor's attributions are the following: a) To watch for the compliance of these regulations and the agreements, resolutions and clauses approved in General Assemblies and in Board of Directors meetings. b) To examine, review and analyze the Treasury's income and expenses accounts and to submit the

TRANSLATION

corresponding report whenever required. c) All other functions assigned in accordance with his attributions. **ARTICLE 26.- ON THE BOARD OF DIRECTORS MEMBERS.** On the President and Vice-President, the Secretary and Under-Secretary, or the Treasurer and Vice-Treasurer temporary or definitive absence they would be replaced by the Board members in its order. The Board of Directors members shall also perform the functions assigned to them by the Board of Directors and shall be part of the Committees, Commissions and work groups that the Board of Directors establishes. **CHAPTER VII – THE NETWORTH.** **ARTICLE 27.-** FUNDARBOL's networth is constituted by: a) the ordinary and extraordinary agreed contributions, by the voluntary contributions perceived from its members, from other natural or juridical persons, from public, private, national or international institutions or foundations, or from the State of Honduras through annual allocations in the nation's budget, from donations in cash or goods, and others. b) The funds coming from the activities developed by FUNDARBOL. c) The legacies and donations that natural or juridical persons and institutions of noble sentiments and altruist and environmental spirit would make to fund the programs and projects that FUNDARBOL undertakes or wishes to undertake d) The personal and real properties that by any title or concept become FUNDARBOL's property, as well as inheritances, legacies, and donations. **CHAPTER VIII. GENERAL REGULATIONS.** **ARTICLE 28.-** What has not been anticipated in these statutes shall be solved by the General Assembly, provided that such decision does not oppose the country's laws, the moral conventions, and FUNDARBOL ends and shall have all the corresponding legal effects. **ARTICLE 29.-** These Statues may be reformed at a General Assembly meeting, expressly convoked to that end, with the vote of two thirds of such Assembly. **ARTICLE 30.-** For FUNDARBOL dissolution the vote of two thirds of an expressly convoked Extraordinary General Assembly shall be required. In case such a resolution is taken, a liquidation of the net worth and the balance that would result should be transferred to: a) **FIRST.** By a majority vote, to a non-for-profit environmental organization with similar ends. b) In case of not reaching an agreement, to the State of Honduras. **SECOND:** The "FUNDACION APADRINE UN ARBOL" (FUNDARBOL), shall submit to the

TRANSLATION

Secretariat of State in the Offices of Government and Justice the audited financial statements that reflect the income, expenses and all the economic and accounting movement, indicating its present net worth, as well its modifications and variations, including inheritances, legacies and donations through a legalized accounting system. The inheritances, legacies and donations coming from abroad, shall be subject to the country's juridical norms, applicable as the case may be, through the State Organs constituted to verify their transparency. **THIRD:** The FUNDACION APADRINE UN ARBOL (FUNDARBOL) shall be registered at the Secretariat of State in the Offices of Government and Justice, indicating the full name, the exact address, as well as its representatives and other Board of Director members names; likewise, it shall be subject to the requirements that within its juridical frame work correspond to this Secretariat of State, through the respective internal organ, verifying the compliance of the objectives for which it was constituted. **FOURTH:** The FUNDACION APADRINE UN ARBOL (FUNDARBOL) SUBJECTS ITSELF TO THE LEGAL AND POLITICAL REGULATIONS established by the Secretary of State in the Offices of Government and Justice and to all other State control entities, facilitating any document required to guarantee the administration transparency, besides remaining obligated to submit periodical annual reports on the activities carried out with institutions or organism with which it relates in the implementation of its objectives and ends for which it was authorized. **FIFTH:** The "FUNDACION APADRINE UN ARBOL (FUNDARBOL)" dissolution and liquidation shall be made in conformity with its statutes and the laws in force in the country and, once the contracted obligations are paid, the surplus shall become part of a legally constituted organization in Honduras with similar objectives or to one welfare organization. Such a process shall be made under the supervision of this Secretariat of State, to the effect of guaranteeing the compliance of the obligations and transparency of the remaining goods referred to in the first paragraph of this same article. **SIXTH:** The present statutes shall come into force after they are approved by the Executive Power, published in the Official Daily paper "La Gaceta", with the limitations established in the Constitution of the Republic and in the Laws, their reforms or modifications; the reforms or modifications shall be

subject to the same procedure for their approval. SEVENTH: The present resolution should be registered in the Registry of Sentences of the Real Estate Registry Office, as established in Article 2329 of the Civil Code. EIGHTH: Prior to the emission of the present resolution certification the interested party should accredit payment of One Hundred and Fifty Lempiras (L.150.00), in conformity with Article 33 of the Legislative Decree No. 194-2002, which contains the Financial Balance and Social Protection Law. TO BE NOTIFIED. (Original signed) JORGE RAMON HERNANDEZ ALCERRO. SECRETARY OF STATE IN THE OFFICES OF GOVERNMENT AND JUSTICE. (Original signed) JOSE OSWALDO GUILLEN. SECRETARY GENERAL."  ESTATUTOS DE LA "FUNDACION APADRINE UN ARBOL" (FUNDARBOL)
 CAPITULO I. INTRODUCCION. ARTICULO 1.- Créase la Fundación "APADRINE UN ARBOL", como una institución de carácter privado, sin fines de lucro, estrictamente apolítica, de duración indefinida y patrimonio propio, cuyo domicilio será Tegucigalpa, Municipio del Distrito Central, que en adelante se reconocerá como FUNDARBOL y se regirá por los presentes estatutos. ARTICULO 2.- La "FUNDACION APADRINE UN ARBOL", tiene como principio fundamental el que expresado por la Organización de Estados Americanos en su Programa Interamericano de Acción para la Conservación del Medio Ambiente, que "Toda persona tiene el derecho fundamental de habitar en un medio ambiente propicio para llevar una vida digna y gozar de salud y bienestar". ARTICULO 3.- La Fundación "APADRINE UN ARBOL" tendrá la siguiente finalidad: a) Ejecutar, promover y aplicar toda actividad de FUNDARBOL a proteger, conservar y solucionar problemas relacionados con las necesidades ecológicas de Honduras, y el bienestar de la población de acuerdo a la Constitución de la República, sus leyes, reglamentos, y de acuerdo a los lineamientos establecidos a través de las instituciones especializadas del país. b) Ejecutar, aplicar y gestionar actividades y prácticas agroforestales para: ampliar la cobertura y las funciones benéficas ambientales de las políticas vigentes en materia de repoblación forestal, integral, y c) Promover el desarrollo agroforestal sustentable y la educación práctica ambiental en áreas rurales, bajo la jurisdicción de las municipalidades nacionales, con el propósito de concertar a nivel de patronatos y cooperativas comunitarias, unidades de custodia para proteger los bosques forestales. e) Fomentar la implementación de las Primarias Comunitarias, programas prácticos de educación ambiental y cualquier otra forma de cooperación tendiente al bienestar progresivo de los hondureños. ARTICULO 4.- LOS MIEMBROS. ARTICULO 4.1.- Serán miembros de la Fundación las personas naturales o jurídicas que, al tiempo de fundarse suscriban la Acta de Constitución y las que posteriormente sean propuestos por la Junta Directiva. Los miembros de la Fundación gozarán de los mismos derechos y tendrán las mismas obligaciones. Habrán los siguientes tipos de miembros: A. SOCIOS COLABORANTES O APORTANTES: Que por contribuciones a FUNDARBOL ya sea en efectivo, bienes o servicios pueden ser nombrados por año, y que de común acuerdo se les puede solicitar asistencia, cuotas y demás obligaciones de FUNDARBOL. Después de tres años de ser socios aportantes, estos pueden de común acuerdo ser considerados para

proponerlos como nuevos socios. C. NUEVOS SOCIOS: Son personas de relevante curriculum que la Junta Directiva puede invitar a asociarse como socios con todos los derechos y obligaciones de los socios fundadores. D. SOCIOS JOVENES: Son niños o jóvenes, menores de edad, que pueden integrarse con sus propias directivas, planes y proyectos como asociados de FUNDARBOL en su proyección hacia las futuras generaciones, ellos fijaran las obligaciones de asistencia, cuotas y demás para su propia organización. CAPITULO III. DE LA ORGANIZACIÓN. ARTICULO 5.- La Fundación "PLANTAR UN ARBOL", estará regida por los siguientes órganos: a) La Asamblea General. b) La Junta Directiva. La Junta Directiva podrá nombrar a un Director Ejecutivo que en efecto actúe como gerente de FUNDARBOL, con responsabilidades administrativas, este podrá asistir a las sesiones de Junta Directiva con voz, pero sin voto. CAPITULO IV. DE LA ASAMBLEA GENERAL. ARTICULO 6.- La Asamblea General es el órgano supremo de la Fundación y como tal representa la máxima autoridad. Estará formada por todos los socios fundadores y por todas aquellas personas naturales o jurídicas que de conformidad con estos Estatutos se incorporen a ella, (NUEVOS SOCIOS y SOCIOS APORTANTES.). ARTICULO 7.- Las Asambleas serán Ordinarias y Extraordinarias. La Asamblea Ordinaria se reunirá dos veces al año, la primera en la primera quincena de junio y la segunda en la primera quincena de diciembre. La Asamblea Extraordinaria se reunirá cuando se estime conveniente o será convocada por la Junta Directiva por el veinte por ciento (20%) de los miembros que no tengan pendientes con FUNDARBOL. La Asamblea Extraordinaria conocerá de los asuntos para los cuales fue convocada. ARTICULO 8.- Las Asambleas Generales de la Fundación tendrá las siguientes atribuciones: a) Aprobar el Programa Interio o modificarlo por medio de la política general de la Fundación. b) Conocer, discutir, aprobar, modificar, aprobar o impondrá las sanciones para el siguiente año en la Asamblea de diciembre. c) Conocer los estados financieros de la Fundación. d) Elegir cuando proceda los integrantes de la Junta Directiva. e) Nombrar DIRECTOR EJECUTIVO que en efecto actuará como un Gerente de FUNDARBOL. h) ELABORAR EL REGLAMENTO DE ATRIBUCIONES Y RESPONSABILIDADES DEL DIRECTOR EJECUTIVO y cualquier otro reglamento requerido para el buen funcionar de la institución. ARTICULO 9.- Para la celebración de las Asambleas Ordinarias y Extraordinarias el quórum legal en primera convocatoria será la mitad más uno de los miembros que estén al día en sus cuentas con FUNDARBOL y, en segunda convocatoria, cualquiera que sea el número de miembros que asistan. La reunión en segunda convocatoria se podrá efectuar dos (2) horas después de citarse en primera debiendo anunciarse ambas convocatorias en un mismo anuncio. ARTICULO

10.- Las convocatorias a las Asambleas Generales serán hechas por la Junta Directiva a través del Secretario en la siguiente forma: a) Por escrito a cada uno de los miembros enviada a la última dirección que la Fundación tenga de éste. CAPITULO V.

ARTICULO 23.- DEL TESORERO. 





WHAT IS THE ONE NATURAL COMPONENT THAT ALL HUMAN BEINGS ON PLANET EARTH SHARE?

The nursery participants are initially taught and provided with all the basic and necessary materials to establish the nursery, after that they do not receive any payment until the plants are mature enough to plant in the fields, usually it takes anywhere from 3 to 9 months, depending on the species, the altitude, the availability of water and other factors. They receive automatic payment for the plants once of appropriate growth is achieved (approximately one foot tall) and additionally they receive another payment if they themselves plant them in the deforested surrounding areas. They also learn to sell plants and make a higher utility, with the goal of eventually making them indepent and highly contious of the necessity and urgency of reforesting their area.

We may ask and of what consequence is this organization compared to any other in the world?

As initially explained we share ONE COMMON ATMOSPHERE so a tree planted in CENTRAL AMERICA and the oxygen it provides through the process of photosynthesis whereby the trees consumes the venenous carbon dioxide converting it into wood, benefits directly the immediate area but the prevailing wind currents move the beneficial oxygen across frontiers and borders benefiting the WORLD!

Although this social, ecological and economic program has initially taken hold in HONDURAS it is expected to grow to all countries of the region. **WHY? Because the poverty of the people is alarming, according to INTERNATIONAL AND UNITED NATIONS STATISTICS more than 60% of the population lives below the poverty level, and of these more than 40% live in extreme poverty or in destitute conditions.**

Adding to the terrible poverty levels the deforestation is rampant, affecting even more particularly the most poor depriving them of: oxygen, drinking water, lumber, fruits, medicines and multiple other benefits which the tree and the forest can provide. According to the NATIONAL FORESTRY SCHOOL OF HONDURAS the country lost 33% of its forests just between 1965 and 1993. FUNDARBOL (SPONSOR A TREE FOUNDATION) is forecasting that if the trend continues and we do not concentrate extreme dedication and receive much needed help to stop the depredation the region will become semi-desertic by the year 2050. **A MINIMUM OF ONE TREE IS LOST EVERY SECOND, THE 365 DAYS A YEAR. This directly affects the entire global atmosphere!**

FUNDARBOL initiated its activities to in the early 1990's to reforest around LAKE YOJOA IN HONDURAS and its surrounding drainage basins. The FOUNDATION initially only worked through other non-profit and well known serious organizations such as: ECO LAGO FOUNDATION, AMITIGRA FOUNDATION, AMUPROLAGO, CODDEFFAGOLF, PASTOR FASQUELLE FOUNDATION AND ASOCIACION COPAN. of **FUNDARBOL** as are his brothers, well known citizen/businessmen of CENTRAL AMERICA.

On January 30th. 2003, with the auspices of the TEGUCIGALPA CHAMBER OF COMMERCE AND INDUSTRY **FUNDARBOL** was legally constituted as an indepent ecological entity, having received its official charter from the Government in August of this same year. Anybody interested in receiving the names of the founding charter members and other backers is welcomed to ask for it through this web site. The FOUNDATION has signed important treaties with the UNITED NATIONS NATIONAL PARK and with the BOY SCOUTS and also the ARMED FORCES to aid in the reforestation effort. One of our principal backers is BANCO ATLANTIDA, S.A. a commercial bank with more than 115 branches throughout the area, the first financial donation to **FUNDARBOL** was received from the CENTRAL AMERICAN BANK FOR ECONOMIC INTEGRATION (BCIE) which has branches in all the countries of the region and through it **FUNDARBOL** proposes to expand its operations throughout the istmus of Central America.

PRINCIPAL OBJETIVES OF FUNDARBOL

The foundation promotes the conservation, the protection and the reforestation of CENTRAL AMERICA particularly oriented to the children through the public and private school system of the area. Trained promoters give motivational seminars to the youngsters leaving them PRACTICAL MANUALS ON ECOLOGY authored by DR. ABRAHAM A. ARCE one of our founding members, as well as illustrative brochures and posters. **FUNDARBOL** believes firmly that **only by motivating and education our youth can the environment be preserved for future generations.**

Another main activity of the Foundation is the establishment of REGIONAL NURSERIES where initially the main activity is to grow trees to reforest the surroundings. The participants are also motivated to plant medicinal and ornamental plants and instill in them the sales and promotion aspects so as to eventually turn the nurseries into a self sustaining and enterprenurial activity, to in effect make its participantes become self sustaining and economically active. **SINCE A GREAT COMPONENT OF OUR PARTICIPANTS ARE UNWED MOTHERS, MOSTLY ABANDONED BY THEIR SPOUSES THIS DIRECTLY BENEFITS THE CHILDREN.** The participants who dedicate to working in the nurseries can receive a salary much above the MINIMUM SALARY paid in the region. **FUNDARBOL thus benefits the human and social aspect as well as benefiting the ecological environment.**
