
Thank you for speaking with me yesterday regarding the steps necessary to "keep the lights on" at the park. As we discussed, my client is in an awkward situation where due to the death of his father he has assumed the operations of this mobile home park only to discover the annual filings were overlooked resulting in a corporate dissolution. Making matters worse, the corporation is unable to simply reinstate as the name is too similar to other corporations. Finally, the power company has threatened to turn off the power to all tenants in the park because the corporation was dissolved.
