Our company began working on the contract for Spacelift Range Systems at Patrick AFB, Florida on 1 January 2001 although we had two employees performing start up functions in November of 2000. At that time our Company, a Women Owned Small Business, had approximately ten employees, and the Vice President made inquires as to what requirements were needed to conduct business in Florida. Unfortunately, we did not have a lawyer at that time or support staff to help us. We were informed of the unemployment taxes to be paid and a reference was made to Florida Statue 607.1502. When we researched that statute, we, unfortunately, did not read the other statutes. The decision was made that it was designed for "Foreign" (out of the United States) Companies and that it didn't apply to us, since we were working only on the Federal Installation at Patrick AFB.

We request that you consider giving us the lesser penalty of \$500 per year considering the lack of maturity of our small business at the time, the erroneous decision that was made, and the verbage of the statute that misled us.
