Pursuant to our recent telephone conversation I am writing to request that the Division of Corporations waive the potential penalties for non-registration of G3, Inc. with the Florida Department of State.

The corporation first opened an office in Florida on July 1, 1999. At that time the corporation was not conducting business as defined by Section 607.1501 of the Florida Statutes. The company had one sales representative in the state who simply took orders for product. These orders or contracts had to be ratified and approved by the home office located in Lowell, Massachusetts.

It was during the fall of 2001 that the company actually began manufacturing a product called a stencil in Florida, and, as we have recently became aware, qualified as conducting business under the statute at that time. The corporation does business in four other states and was not required to register in those states, and erroneously assumed the same situation existed in Florida. The company understands that each state has its own requirements and attempts to comply with the laws of each state they conduct business with.

The corporation in good faith attempted to adhere to all regulations of which they were aware. They registered with the Department of Revenue for income and sales tax filing as soon as they became subject to those rules. The company has filed these returns and paid any taxes due in a timely manner and would have done the same regarding the registration process and annual report filing if it had been made known to them at an earlier date.

At no time during their initial tax registration or the intervening 2 to 3 years was the company ever notified of the requirement to register. It was not until the corporation received a notice in 2003 from your office that they became aware of this requirement. If the company had been notified earlier they certainly would have complied.

The company immediately attempted to comply; however, part of the registration process consisted of obtaining an original Certificate of Existence from Massachusetts. This certificate was not received for over 2 months which delayed the initial registration. The corporation sent the first registration at the end of 2003 and believed the registration process complete. In April 2004 the company was again notified that they were not registered. Our firm followed up by calling your office and was notified that the original registration application was never received and we had to resubmit. This required that we obtain another original Certificate of Existence from Massachusetts, which again delayed the filing of the application.

G3, Inc. respectively requests that you consider the factors involved, their attempts to comply with the registration process, their good standing with the state tax agencies and that the company has been a viable contributor to the State of Florida.

We hope you would consider one other factor in your decision. Although the company operates in five states it is still a small closely-held business. The company has been trying to increase its labor force and reinvest in operations now that the economy seems to be turning for the better. Any costs incurred that detract from this goal only hurt's labor prospects and the future expansion of its operations.

In speaking with the President of the company, she understands that although penalties may be assessed, she believes the company's good faiths efforts and other factors discussed in this letter should help to waive or minimize those penalties, if indeed they are assessed.
