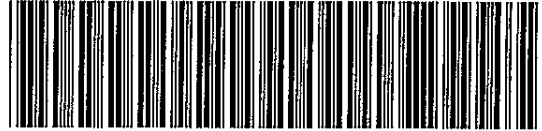


I have reviewed your letter dated June 13, 2003 and would like to give you some additional information. I operated a business in Orlando, FL during the early 1990's. The only state requirements I had to operate that business was to have city and county business licenses and to make timely payments of my sales taxes. I moved to Alabama in 1995 to pursue another line of work and closed my Florida business.

I opened a new business in 1996 and in July of 2001, began to do business in Florida. At that time, I acquired business licenses for Santa Rosa and Okaloosa counties. I also registered with the Florida Department of Revenue and have always reported and paid my sales taxes on or before the due date.

The reason I am giving this background is to let you know that there was no intent on our part to defraud the State of Florida any money owed to it. It never occurred to me that I needed to register my company with any entity other than the proper licensing (county and city) and taxing authority. I am asking that you give consideration to the above facts and relieve me of the \$2300.00 fine for failing to register as a foreign corporation. I do not have a problem paying the fees owed for the previous two years.

I am writing to address the issue of obtaining a Certificate of Status so that I may obtain our Contractors license and properly operate in Florida. This issue was addressed in 2003 and I had been told it was all taken care of. The employee responsible is no longer with the company.


I am a resident of Florida and 5 of our employees are Florida residents. My home and my partners home were both destroyed by the hurricane and several employees homes were severely damaged. Many of our business customers were shutdown for several months and have also experienced business downturns.

Since Hurricane Ivan, Magnolia Belle Data Systems, Inc. has sustained a significant downturn in revenues directly attributable to the Hurricane and it's effects. We have managed to pull through this to a period of increasing opportunities for which we need to have all licensing issues resolved to take advantage of.

I have located the letter we discussed dated 23 Jul 2003. I am requesting the \$1300.00 fees and penalty be reduced as much as possible and we be allowed to pay the remaining fees in 90 days. At this point \$1300.00 will place a significant hardship on the company. Officers of the company have not been paid regularly since September to allow operations to continue and meet payroll and other obligations. I have also enclosed a copy of the Certificate of Domestic Corporation from the State of Alabama.


