



Following up on your telephone conversation this morning with my assistant, Larry Markes, I write in response to your letter dated February 24, 2004 (a copy of which is enclosed for your convenience, as requested).

We act as general counsel for this organization. The Bright Media Foundation is a California nonprofit corporation which is exempt from federal and state taxation. Enclosed are copies of the determination letters issued by the Internal Revenue Service and the Franchise Tax Board (the state taxing authority) on September 8, 2003 and December 15, 2003, respectively.

This organization is a religious corporation, as shown in its Articles of Incorporation (a copy of which is also enclosed). Its primary purpose is to continue the work of Dr. William R. Bright, a world-renowned evangelist who passed away last year. Dr. Bright was the founder of Campus Crusade for Christ, an international organization which has its headquarters in Orlando. The Bright Media Foundation holds title to all of the literary works of Dr. Bright and his wife, Yonette Bright, herself a well-known Christian leader. The Bright Media Foundation furthers its religious mission to assure the wide dissemination of those literary works by providing them at or below cost.


We recently submitted papers to qualify the Bright Media Foundation in Florida. We were unaware that the corporation had actually opened a bank account and conducted other activities in Florida for quite some time prior to sending you the application, but we did record the first date of doing business as accurately as we could. We submitted the application for authority to conduct business affairs very soon after receiving the determination letter from the state in December. Your February 24th letter was in response to this submission.

(Your letter contains a slight error in its second sentence. As confirmed in a telephone conversation in February, the documents we submitted have been retained by your office.)

Because the entity is a religious nonprofit, the proposed penalty assessment of \$1,000 per year constitutes an extreme hardship. However, I note that Section 607.1502(c), Florida Statutes, states that the penalty "shall be not less than \$500 or more than \$1,000 for each year or part thereof during which it transacts business in [the] state without a certificate of authority." Accordingly, we respectfully request that the penalty be reduced to \$500 per year for the two years the organization operated in Florida without a certificate of authority. If the total amount due is reduced to \$1,300, I am confident that our client will be able to pay the revised figure immediately.

We look forward to your prompt reply. Of course, please feel free to contact me at your earliest convenience if there are any questions or other comments about the foregoing or any of the enclosed documents or this corporation.






