

Per our telephone conversation this afternoon, I am writing on behalf of my client referenced above, to request a waiver of the penalty fees assessed on the basis of their having conducted business prior to their qualification in the State of Florida.

On the application for authorization to transact business, we indicated a business commencement date of January 1, 2002. This date was indicated based on the first year for which the corporation filed a Florida Corporate Income Tax Return. This was an incorrect date as far as the commencement of business date in Florida is concerned. We incorrectly associated the corporate tax return date with the commencement of business date.

The corporation provides logistic services to its clients. The corporation did not have any clients in Florida in 2002, 2003 and 2004 and did not receive any revenue from Florida sources in those years. The corporation's client is a California business which had warehousing requirements located in Florida, and engaged Morgan Air Freight Corporation to provide logistic services in Florida by way of employing Florida workers. The gross sales revenue associated with these services is paid by the California client to Morgan Air Freight Corporation and is California source revenue. For 2002, 2003 and 2004 Morgan Air Freight Corporation did not have any customers in Florida, it did not solicit clients in Florida in those years, and it had no revenue which was Florida source revenue for those years. Thus, it is our contention that though the corporation had a Florida tax filing requirement, it was not doing business in Florida in those years and was not required to seek qualification for those years.

Based on the information herewith submitted, we are respectfully requesting that the proposed assessment of penalties for conducting business prior to qualification be abated, and that the qualification date be revised to 2005 - which is the year in which the Application by Foreign Corporation for Authorization to Transact Business in Florida was submitted.




