

With respect to your letter of March 28, 2005, my client respectfully requests an abatement of penalties arising out of their unauthorized "business" in Florida.

My client operates a Church in New Jersey that has been serving their congregation since 1980. They have over 200 members in their congregation, operate a daycare center for their members, and are engaged in numerous community activities with in New Jersey. Please note my client obtained 501C3 status over a decade ago.

Approximately 2001, an assistant minister of my client commenced a church in the state of Florida. After opening same, she requested that Gospel Light Church of God in Christ Jesus, Apostolic, Inc. take over the operation. There were only eight members, and the sole activity was services on Sunday and a bank account to pay rent, telephone and insurance. The donations of the Florida members were insufficient to pay the overhead, and same was subsidized by my client's New Jersey

operation. On or about February, 2005, my client disassociated from the physical church which existed in Florida, and will be renting and starting a new operation once approval is received from the State of Florida.

When my commenced services in Florida, they were unaware that they had to receive authority from the State of Florida. Their mistake is no excuse for violating the law, but as a non profit charity, it is respectfully requested that the State of Florida waive all penalties.

Your cooperation is greatly appreciated.


