Attention Brenda Tadlock,

I am writing this letter to please request that you waive the penalties to qualify JGRF Realty Corp. in the state of Florida.

The reason for my request to waiver penalties is as follows:

With the decision to purchase Florida Properties we were working with a Florida Consultant, Dedra Ebersbach. Dedra Ebersbach is the head of Carlisle Companies Inc. and Carlisle Properties Inc.; she is also a licensed Real Estate Agent in the State of Florida. We hired her to help find properties in Florida and to help in the management of the properties and to advise us on Florida regulations.

We are currently suing Ms. Ebersbach for fraud and embezzlement in excess of \$100,000. Our attorneys have sent out demand letters and we are filing a civil complaint on or before July 3, 2005. We have also reported Ms. Ebersbach's actions to the Florida Department of Law enforcement.

We ask that you please take this into consideration. We hired Ms. Ebersbach with the intention of making sure we followed all Florida Regulations and she completely disregarded our needs and requests.
