Dear Mr. Bryan:

AmeriII ealth Administrators, Inc. ("AAI") recently submitted to the Department of State an application for a certificate of authority to transact business as a foreign corporation. The Department responded with the attached letter (Letter No. 504A00050462) advising AAI that it would be assessed \$4600 for (i) its delay in applying for a certificate (\$4000) and (ii) its failure to file annual reports and pay related fees (\$600).

AAI's Tallahassee counsel, Timothy Schoenwalder, contacted the Department last week and was advised that the \$4000 penalty could be reduced by up to \$2,000 if the Department determines that the facts and circumstances so warrant. I am writing to request that the Department grant a reduction for the reasons set forth below.

AAI is a Pennsylvania corporation, and one of a group of related AmeriHealth companies with home offices in the Philadelphia area. AAI is an affiliate of AmeriHealth of Florida, Inc., a Florida corporation that, until recently, operated a Jacksonville-based HMO licensed by the Florida Department of Insurance.

For strategic business reasons, a decision was made in 2000 to wind down the Florida HMO operation. However, rather than terminate all AmeriHealth of Florida personnel, AmeriHealth elected to transfer certain employees from the Florida company to AAI, which was interested in using the Jacksonville location to process claims for group health plans located in other states. As a result, a number of Florida jobs were saved, and AAI has since added additional positions in Jacksonville.

The foregoing was essentially a transitional process, and an unintended consequence was the inadvertent failure of AAI to qualify as a foreign corporation before adding Florida employees to its payroll and becoming active at the Jacksonville location. AAI is, however, up to date on its Florida tax filings, and AmeriHealth of Florida is current on tax and annual report filings.

AAI's omission in failing to timely secure a certificate of authority from the Department of State was entirely unintentional, and did not result from any desire to avoid compliance with Florida law or with any tax or other obligation arising thereunder. Furthermore, the same process that resulted in AAI's inadvertent non-compliance also resulted in the preservation of the jobs of Florida residents.

In light of the foregoing, AmeriHealth respectfully requests that the Department reduce to \$2000 the penalty imposed on AAI.
