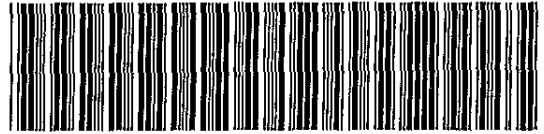

RESTATED CERTIFICATE OF INCORPORATION
OF
HOUSE OF DISCIPLES CHURCH OF JESUS MINISTRIES, INC.

Under Section 805 of Not-for-Profit Corporation Law

THE UNDERSIGNED, for the purpose of restating in a single certificate the text of its Certificate of Incorporation as amended, does hereby certify:

1. The name of the Corporation is **"HOUSE OF DISCIPLES CHURCH OF JESUS MINISTRIES, INC."**

2. The Corporation's Certificate of Incorporation was filed by the Onondaga County Clerk's Office on SEPT. 26th, 2003, pursuant to Article 2 of the Religious Corporation Law. 20030526-INDEX#

3. The Certificate of Incorporation is amended and restated to include the following text set forth herein, as authorized by vote of the initial board of directors, which shall supercede the contents of the original Certificate of Incorporation.

4. The Corporation is a corporation as defined in subparagraph (a)(5) of Section 102 of the Not-For-Profit Corporation Law and is a Type B Corporation.

5. The purposes for which the Corporation is formed are as follows: to provide a religious institution to enable its members to meet for divine worship, engage in religious activities and follow other religious observances in the Christian faith.

In furtherance of the foregoing purposes, and subject to any limitations provided in the Not-For-Profit Corporation Law or any other statute of the State of New York, the Corporation shall have the power, either directly or indirectly, either alone or in conjunction

or cooperation with others, to do any and all lawful acts and things and to engage in any and all lawful activities which may be necessary, useful, suitable, desirable, or proper for the furtherance, accomplishment, fostering, or attainment of any and all of the purposes for which the Corporation is organized, together with the power to solicit and receive grants and contributions from private and public sources, and to aid or assist other organizations whose activities are such as to further, accomplish, foster or attain any of such purposes. Notwithstanding anything herein to the contrary, the Corporation shall exercise only such powers that are in furtherance of the exempt purposes of organizations set forth in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), and the regulators thereunder, as the same now exist or as they may be hereafter amended from time to time.

6. The Corporation is organized and shall be operated exclusively for public and religious purposes as defined in Section 501(c)(3) of the Code, thereby to promote social welfare, and is not formed for pecuniary profit or financial gain.

7. The office of the Corporation is to be located in the County of Onondaga, State of New York.

9. All income and earnings of the Corporation shall be used exclusively for its corporate purposes. No part of the net income or net earnings of the Corporation shall inure to the benefit or profit of or be distributable to its members, directors, officers, or other private persons. Notwithstanding the foregoing, the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of the Corporation set forth in Paragraphs 3 and 4 hereof. No member or director of the Corporation shall receive any salary, other compensation, or pecuniary profit of any kind for services as such member or director other than reimbursement of actual and necessary expenses incurred in the performance of his duties.

10. Notwithstanding any other provision of this Certificate, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income taxation under Section 501(c)(3) of the Code, as amended, or by a corporation, contributions to which are deductible under Section 170(b)(2) of the Code. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation. The Corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

11. The Corporation may be dissolved only upon authorization of the Board of Directors at a special meeting called for that purpose. Upon the dissolution of the Corporation, all of the remaining assets and property of the Corporation shall, after necessary expenses thereof, be distributed to such organizations as should qualify under Section 501(c)(3) of the Code and are organized and operated exclusively for charitable, scientific, religious or


educational purposes, no part of the net earnings of which inures to the benefit of any private shareholder, member, or individual, and which does not carry on propaganda or participate or intervene in any political campaign. The corporations, funds, or foundations to receive said property shall be chosen by the existing Board of Directors.

12. The duration of the Corporation shall be perpetual.

13. The Secretary of State of the State of New York is hereby designated the agent of the Corporation upon whom process against the Corporation may be served. The post office address to which the Secretary of State shall mail a copy of any process against the Corporation served upon him as agent of the Corporation is:
