

Thank you for your letter of August 5, 2005, outlining the steps that Top Echelon Contracting, Inc., must take to obtain a Certificate of Authority to conduct business in Florida. Also, thank you for our telephone conversations regarding the same.

Top Echelon Contracting, Inc., is a temporary help service engaged in supplying white collar employees, secretarial employees, clerical employees, and/or skilled laborers to various clients throughout the United States. As I noted during our last telephone conversation, Top Echelon has always paid applicable taxes (including those related to the sale of its services, income taxes, unemployment, worker's compensation, etc.) to each state in which it has done business over the years. However, for many years its management did not know that the company should have also sought authorization to conduct business in each state.

When I caught this problem, I immediately began a concerted effort to certify Top Echelon in each of the 49 states and territories in which it does business. In the case of Florida, Top Echelon could have adopted an interpretation of the exceptions to doing business set forth in Section 607.1501 Florida Statutes. However, upon close examination of the facts and circumstances surround Top Echelon's transactions in Florida, it appears most likely that Top Echelon unintentionally did business within the State of Florida from 1993 to present day without first obtaining a certificate of authority.

In defense of Top Echelon's actions, I offer its management's lack of knowledge and understanding of each state's corporate certification requirement. Furthermore, I would submit that at first blush a lay person might conclude that Top Echelon's business fits within one or more of the exceptions contained in Section 607.1501 Florida Statutes. Therefore, in light of these facts and the fact that Top Echelon has opted to voluntarily disclose this problem, I respectfully request that the Florida Department of State only penalize Top Echelon at the statutory minimum penalty of \$500 per year.

Thank you very much for your time and consideration in this matter.
