TOLL MUNICES FLORIDA

Article Fifth

Each of the holders of the issued and outstanding shares of Common Stock of the corporation shall have the right to subscribe for any new capital stock, whether of a class now existing or hereafter created, or for any securities convertible into capital sock hereafter issued by the corporation in proportion to their respective holdings of stock at the time of such issue.
