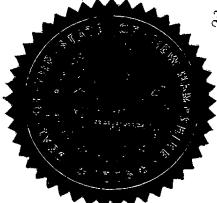

THE UNDERSIGNED, ACTING AS INCORPORATOR(S) OF A CORPORATION.
UNDER THE NEW HAMPSHIRE BUSINESS CORPORATION ACT, ADOPT(S) THE

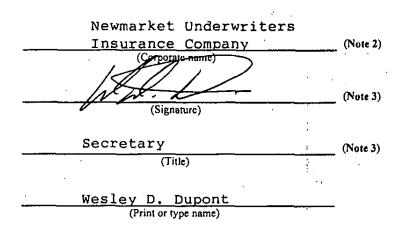
