Per the attached letter from your office my poor and small and almost bankrupt little company owes the State of Florida \$1,150 for an administrative mistake on my part. This letter is a request, almost a plea, to ask your help in reducing the penalty.

My story:

I lost my corporate job, in Colorado, in December 2003. I began looking for new opportunities and decided my best bet was to open a company. I opened a company in Colorado (since that was where I lived at the time) and subsequently moved to Florida to be closer to family and the territory my new business encompassed. Hurricane Ivan came along shortly after we moved to Gulf Breeze and nearly destroyed our neighborhood (still a big mess around here). My company got off to a very slow start and cash is very tight. My new accountant asked me a month or so ago if I had registered in Florida, which I hadn't. Not because I was flagrantly disregarding the rules, but because I am new to the business ownership stuff and had no idea I had to register. (My company does business coaching, to existing businesses needing help in marketing, business planning, management, etc. - not in starting up a business, and I did check and was told that my company would not have to pay sales taxes on coaching services – I knew I would have to register if I paid sales taxes but since I didn't it didn't occur to me that I would have to register.) I know better now and as soon as I found out that I had to register, I did.

So that's my story, my request is to have the fine greatly reduced to something I can afford or eliminated in its entirety.
