Dear Mr. Bryan:

This letter is in response to a notice received by the above-referenced taxpayer. A copy of the notice is enclosed. Also enclosed is the original application for authorization to transact business in Florida, which was returned to the taxpayer. The taxpayer is being penalized for transacting business in Florida without registering with the Department of State.

Of pivotal importance is the taxpayer has minimal business activity in Florida and voluntarily registered with the Florida Department of State.

We feel that the taxpayer should not be penalized due to the following facts: Recently the taxpayer changed accountants and a new controller took over. The former controller handled much of the tax compliance function. Lacking the requisite sophistication in dealing with multiple-state situations, he was not aware that a nexus situation existed with Florida. He did file sales tax returns, as noted in Florida's initial request for corporate tax returns. He was simply not aware of the applicable registration rules, and surely would have filed the appropriate forms had he been aware of these rules. Therefore, the act of not registering was not done with a malicious intent.

When we took over the tax function, an inquiry was made regarding activity in other states. As luck would have it, shortly thereafter, a notice was received from the Florida



Department of Revenue. Prior year tax returns were then immediately prepared and filed as were the required forms to register with your department. The taxpayer is in good standing with all tax agencies with whom it is required to file forms and will continue to be in compliance with Florida's requirements.

Therefore, the taxpayer respectfully requests that the \$1,000 per year penalty totaling \$3,000 be abated. A check is enclosed for the prior-year filing fees totaling \$450.


