Dear Mr. Rivers:

We have received your correspondence dated July 27, 2005. In that correspondence you have enclosed a copy of Section 607.1501 which attempts to partially define "transacting business." Although Kyp-Go does not appear to neatly fit into any of the exceptions in Section (2) it may not be transacting business in this state. Essentially, Kyp-Go, Inc. has a small lab for research and design wherein they engineer prototype light bulbs. Kyp-Go does not manufacture or sell bulbs to the public out of this location and any prototypes that are developed are then manufactured in Missouri and shipped to consumers throughout the United States directly from the manufacturer. Is it possible they fit into the 607.1501(2)(I)?

If the Department's position is that these activities do constitute transacting business within the state then since Kyp-Go is attempting to voluntarily comply by applying as a Foreign Corporation for Authorization to Transact Business in Florida we ask that you waive any penalty. Legal commentators have suggested that the "purpose of Section 607.1502(4) is to induce foreign corporations operating in the state without authority to obtain a certificate of authority without the imposition of harsh sanctions" and further that "the \$500 to \$1,000 civil penalty is not required to be paid unless proceedings are brought by the department to collect it." See enclosed pages 13-14 and 13-15 from the Florida Corporate Practice book.

Enclosed is the application with the corrected taxpayer identification number along with a check in the amount of \$150.00 for the fees that would have been imposed had Kyp-Go, Inc. registered in 2004, however, if you find that Kyp-Go,
